NORTH 48 BICYCLES LTD. and its directors, officers, employees, instructors, guides, agents, representatives, independent contractors, subcontractors, suppliers, sponsors, partner agencies, successors and assigns (all of whom are hereinafter referred as "the Releasees")

DEFINITION

In this Release Agreement, the term "**Bike Touring**" shall include all activities, events or services provided, arranged, organized, conducted, sponsored or authorized by **North 48 Bicycles Ltd**. and shall include, but is not limited to engaging in guided travel by bicycle, foot and motor vehicle, both on public roads and on trails, and related instruction, travel, transport and accommodation; and other such activities, events and services in any way connected with or related to the foregoing.

PROTECTIVE EQUIPMENT and PROPER CONDUCT

I have been informed that it is a requirement of participating in Bike Touring that I wear at all times a buckled approved bicycle helmet.

I agree to abide by **North 48 Bicycles Ltd.**'s rules for participation in Bike Touring (which are available on its website (http://north48bikes.com/contract_terms) and on request from its staff, and which I acknowledge I have read and understand), and to follow direction from **North 48 Bicycles Ltd.**'s staff while Bike Touring.

ASSUMPTION OF RISKS

I am aware that Bike Touring involves many risks, dangers and hazards. The risks, dangers and hazards, including but not limited to: loss of balance; difficulty or inability to control one's speed and direction; variation or steepness in terrain; rapid or uncontrolled acceleration on hills and inclines; mechanical failure of equipment, variation or changes in the riding surface including rocks, gravel; changing weather conditions; exposure to temperature extremes or inclement weather; travel or transport to and from the sites used for Bike Touring, travel on city roads, highways, backcountry roads, trails and across open areas and forest areas; encounters with domestic and wild animals; collision with pedestrians, motor vehicles, cyclists and others; risk resulting from the physical exertion of Bike Touring; failing to ride safely or within the limitations of one's own abilities, negligence of other participants; and NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING THE FAILURE ON THE PART OF THE RISKS RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF Bike Touring.

I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH **Bike Touring** AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM. Further, I confirm that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

Finally, I accept that it is my sole responsibility to determine for myself whether I have the riding skills and experience to participate in Bike Touring.

RELEASE OF LIABILITY. WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of **North 48 Bicycles Ltd.** agreeing to my participation in **Bike Touring** and permitting my use of its services, equipment and other facilities, and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the RELEASEES AND TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury, including death, that I may suffer or that my next of kin may suffer, as a result of my participation in **Bike Touring**, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT, ON THE PART OF THE RELEASEES, AND FURTHER INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF PARTICIPATING IN **BIKE TOURING** REFERRED TO ABOVE:

- 2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES for any and all liability for any property damage, loss or personal injury to anyone in any way connected with my participation in Bike Touring, regardless of the negligence of the Releasees;
- 3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity;
- 4. This Release Agreement and any rights, duties and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of province of British Columbia and no other jurisdiction; and
- 5. Any litigation involving the parties to this Release Agreement shall be brought solely within the province of British Columbia and shall be within the exclusive jurisdiction of the courts of British Columbia.

In entering into this Release Agreement I am not relying on any oral or written representations or statements made by the Releasees with respect to the safety of participating in **Bike Touring**, other than what is set forth in this Release Agreement. I CONFIRM THAT I HAVE READ AND UNDERSTOOD THIS RELEASE AGREEMENT PRIOR TO SIGNING IT, AND I AM AWARE THAT BY SIGNING THIS RELEASE AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.
